- Act 583 helps entrepreneurs by providing businesses with specifics on how and why licensing boards are creating and enforcing rules.

- Act 630 provides survivors of crime access to their own law enforcement investigative records.
- Act 484 implements standardized reporting for collection of firearms by Sheriffs.

2022 Legislative Update State Representative Aimee Adatto Freeman



Friends.

We've wrapped up the 2022 Legislative Session with a balanced budget. And, the legislature was able to fund some needed improvements; pay raises for teachers and school workers, funds to improve reading skills in lower grades, and a record-high increase in funding for higher education that includes pay raises.

The legislature also continued reforming the criminal justice system and passed legislation to address problems in the juvenile justice system. Although not passed unanimously, Louisiana now has a stringent new law covering women's reproductive health and personal medical choice of treatment

This 2022 Legislative Session also dealt with the aftermath of last year's hurricanes, including dispersing federal dollars to be expended in the state.

District 98 neighbors and the City of New Orleans will eventually see direct benefits from the Louisiana Legislature's actions this session; in capital outlay projects the Port of New Orleans is set for \$143.7 Million; Sewerage and Water Board Power Plant, \$71.7 Million; Agenda for Children, \$3 Million; Children's Hospital (behavioral hospital), \$830,000; Foundation for Science and Mathematics Education, \$2.7 Million; NOCCA, \$19.4 Million; Lighthouse for the Blind, \$500,000, and the UNO base budget is at \$108.2 Million; SUNO base budget, \$22.2 Million; LSU Health Sciences Center, New Orleans base budget, \$256.5 Million. Plus, there is money for a study towards a passenger train between New Orleans and Baton Rouge!

Session Highlights

Appropriations/Fundina =

Insurance - Catastrophe Response

Act 754 offers grant incentives to encourage new insurance companies to join the Louisiana property insurance market in the wake of the 2020 and 2021 hurricane seasons

Act 554 creates the "Louisiana Fortify Homes Program" to offer grants retrofit roofs of property with a homestead exemption against catastrophic wind events.

Act 263 establishes standards for communication and status updates between residential policyholders and their insurance companies following a named storm or hurricane.

Act 724 sets a cost-sharing cap of \$75 for a 30-day supply of insulin or a drug formulary and requires formularies to include all classes of insulin.

Act 339 protects retired fire employees from health insurance enrollment discrimination.

Act 114 allows for discretionary group life insurance policies that don't adhere to standard eligibility.

Act 683 increases the penalty up to \$250,000 for a person who knowingly engages in unfair trade practices within insurance.

Act 330 increases the minimum weekly benefit for unemployment compensation.

Motor Vehicles

Act 578 imposes a road usage fee of \$110 per year on electric vehicles and \$60 per year on hybrid vehicles operated on state highways.

Act 762 creates a statewide electric vehicle charging network.

Act 93 and Act 77 require insurance companies to cover the temporary use of a motor vehicle that is not owned by the policyholder.

Act 716 creates an alternative for insurers to receive a certificate o ownership and salvage title for motor vehicles declared to be a total loss.

Act 584 requires anyone wanting to buy or sell catalytic converters to marijuana. register for a business license and maintain records of each transaction.

Act 127 creates a crime for the theft of a catalytic converter or engine control module, provides for penalties, and requires dealers to register with their chief of police and sheriff.

Act 634 requires sustained complaints remain in a law enforcement officer's personnel file, subjects officer personnel files with sustained complaints to public records requests, and provides for whistleblower service who develop cancer post-employment.

Act 219 relates a criminal offender's monetary obligations to their ability

Act 496 Strictly limits solitary confinement time in juvenile facilities to 8 hours with visual and verbal contact every ten minutes, and a mental health practitioner speaking to the subject within each hour to help the juvenile exit solitary as soon as possible.

Act 220 creates the crime of recruitment of juveniles to commit cariacking.

Act 175 clarifies that the district attorney has discretion to prosecute youth in juvenile court or to transfer the case for adult prosecution.

Act 674 requires a child who has been adjudicated of a delinguent act and his parent or legal guardian to participate in a court-approved decisionmaking course.

Act 440 establishes a right of action against commercial entities that publish and/or distribute only internet material harmful to minors.

Act 442 prevents property owners from evicting tenants for 30 days in areas under a federal disaster declaration.

Act 632 enacts provisions regarding repair contracts following natural disasters including cancellation, payments and refunds, notices, and venue

Industrial Hemn

Act 462 creates the Industrial Hemp Promotion and Research Program within the Department of Agriculture and Forestry (LDAF) to enhance research, education, promotion, facilities, and industrial hemp-related activities throughout the state.

Medical Marijuana

Act 438 authorizes dispensing to nonresident patients with qualifying medical conditions and a valid medical marijuana registration in their home jurisdiction.

Act 444 adds medical psychologists and nurse practitioners with prescriptive authority to the list of healthcare providers who can give a valid therapeutic marijuana recommendation

Medical Treatments

Act 676 creates the office on women's health and community health within LDH to coordinate medical policy, treatment programs, and services

Act 253 requires facilities to have a permanently installed generator or seniors the opportunity to register to vote. alternate electrical power source with arrangements for sufficient fuel.

Act 522 Establishes a process for all nursing homes to create a new emergency preparedness plan as a licensing requirement, said plan to

Postsecondary Education

Act 308 creates seamless transfer of course credits in all higher education nathways

Act 205 requires four-year colleges and universities and community colleges to enter into reverse articulation/transfer agreements

Act 601 and Act 549 allow retired teachers to be reemployed without benefit suspension if filling a critical shortage vacancy.

Act 607 requires dyslexia education as a component of teacher education

Act 622 requires charter schools to report screening results of dyslexia and other impediments to learning.

Education

HCR 23 provides for legislative approval of the MFP formula for FY 2022-2023. Includes: an increase in the Supplemental Course Allocation per pupil from \$59 to \$70; a \$2,000 stipend for mentor teachers; an acrossthe-board pay raise of \$1,500 for certificated personnel and \$750 for non-certificated personnel: and the inclusion of the Special School District in the MFP Formula.

Elementary & Secondary Education

Act 588 requires all public school governing authorities to adopt policies regarding installing audio and video cameras in special education classrooms on the request of a student's parent or legal quardian.

Act 624 requires public school governing authorities to provide high school

Act 472 The Support for Pregnant and Parenting Students Act" requires policies in public high schools regarding accommodations for attendance, breastfeeding, and child care for students who are pregnant or parenting.
